#### Thimpu-Punakha-Paro

#### 2 to go

#### Day 01: Arrival and Paro to Thimpu (L/D)

Arrive at Paro airport. After completing immigration formalities and collecting your baggage, our representative will meet you. You'll then drive to Thimpu, covering 55 km in approx. 1.5 hours. Along the way, we'll pause at Chuzon, where the Thimpu and Paro rivers converge. Upon reaching Thimpu, check in to the hotel. In the evening, take a stroll through the local market. Overnight stay at the hotel.

#### Day 02: Thimpu (B/L/D)

Following breakfast, head to Buddha Point and explore the Buddha Nature Trail, a 2-hour hike. Next, continue to Changangkha Lhakhang. After lunch, visit Pangri Zampa, the Bhutan Post Office, a traditional paper-making factory, and Trashichoedzong. Overnight stay at the hotel.

#### Day 03: Thimpu to Punakha (B/L/D)

After breakfast, begin a drive to Punakha, covering 75 km in approx. 3 hours. Along the way, you will pass through Dochula Pass and make a stop to visit Chimi Lhakhang. Upon arrival, check in to the hotel. Later, explore Punakha Dzong, and in the evening, take a stroll through the local village. Overnight stay at the hotel.

#### Day 04: Punakha to Paro (B/L/D)

After breakfast, set out on a drive to Paro, covering 120 km which typically takes about 4.5 hours. Upon arrival, check into the hotel. After lunch, explore Ta Dzong followed by a short trail to Rinpung Dzong. Overnight stay at the hotel.

#### Day 05: Paro (B/L/D)

After breakfast, head out for an excursion to Tigers Nest, a hike lasting approx. 5 hours to one of Bhutan's most renowned monasteries perched on the side of a cliff. The rest of the day is at leisure. Overnight at the hotel.

#### Day 06: Departure (B)

After an early breakfast at the hotel, proceed to the airport for your flight to your onward destination.

Our representative will assist you with exit formalities before bidding you farewell.
